The Gauteng Department of Roads and Transport adhere to all relevant Acts including but not limited to, the Constitution of the Republic of South Africa of 1996, the Black Economic Empowerment Act No.53 of 2003, Preferential Procurement Policy Framework Act No.5 of 2000, Employment Equity Act No. 55 of 1998 and the Public Finance Management Act No 1 of 1999.

Preferential Procurement Regulation, 2017 has been repealed, therefore the Department of Roads and Transport will apply Preferential Procurement Regulation, 2022.

COMPULSORY/MANDATORY TENDER REQUIREMENTS: Failure to submit the following as per required discipline will render the responder's submission disqualified: (Attach professional certificate or provide professional registration numbers)

KEY RETURNABLES: • Tax compliance status pin (A consortium or joint ventures (Including unincorporated consortia) must submit a Tax status pin of each partner in the consortium or joint ventures (Including unincorporated consortia). • Registration Documents of the business with the Companies and Intellectual Property Commission (CIPC) • Certified ID copies of company members and shareholders. • CSD summary report or MAAA number.

Responders shall note that the discipline(s) for which they may apply, are detailed in the Annexures to the Call for Expression of Interest document. Responders may apply for more than one discipline provided qualifying conditions are satisfied.

FUNCTIONALITY CRITERIA: Functionality will be scored out of 100 points, the minimum threshold is 70 points, responders who fail to meet the minimum threshold will not be selected to the panel. (Please refer to Annexure to the Call for Expression of Interest document for detail of weighting and criteria for each discipline)

NB: - Don't submit Cv's (Fill in the B1 form) - Points will only be allocated for Completed B1 forms), fully signed by relevant key personnel and Commissioner of Oath Stamp, (Make copies of the B1 form and fill the form for all your key personnel) - Failure to submit proof of completion Certificate/reference letter will result in the bidder being awarded 0 points Bidders should note the following:

• Functionality will be scored out of 100 points. • Where the proposed prices of critical materials to be supplied to the Department are considerably less than the expected market price or rates, the Department reserves the right to verify the proposed prices by requesting quotations from the supplier(s) cited in the compilation of the bid. • Potential suppliers must note that in terms of Departmental policy, the Department reserves the right to cancel a contract and blacklist any supplier for a period of at least 12 months if the supplier fails to adequately perform in terms of the awarded contract. • The bid validity period is 120 days (excluding public holidays) However, the Department reserves the right to request all bidders to extend such validity period should the need arise. • Prospective bidders should be represented at the compulsory site briefing by suitable/qualified and experienced individuals who can fully comprehend the scope and complexities of the work involved.

The representative attending the compulsory site briefing may only attend on behalf of one bidding enterprise and/or Joint Venture/Consortium.

• The successful bidder will be required to enter into a formal contract with the Department. Such contract will be governed in terms of the General Conditions of Contract dated 2015. • The Department will not compensate the bidder for any costs incurred in the preparation and submission of a bid offer, including the costs of any testing necessary to demonstrate that aspect of the offer complies with requirements.

• **OBTAINING TENDER DOCUMENTS:** A non-refundable amount of R500 (Five Hundred Rand) will be levied per tender document. This amount is payable in debit card between 09:00 and 15:00 at the Finance Section of the Gauteng Department of Roads and Transport, located 45 Commissioner Street, Life Centre building, Johannesburg, Ground floor.

Submission documents will be available for collection by prospective tenderers upon presentation of the appropriate proof of payment to the Department. These documents can be collected on the ground Floor – 45 Commissioner Street, Life Centre building, Johannesburg. Tender documents will be available from the **26 April 2024.**

SUBMISSION OF TENDERS: Clearly indexed Tender Documents together with all applicable attachments must be deposited in the tender box at the foyer of the Gauteng Department of Roads and Transport, 45 Commissioner Street, Life Centre building, Johannesburg, ground floor, by no later than 11:00 on the closing date indicated above. Late tenders (tenders submitted after the closing date and time) will **NOT** be accepted.

Not submitting all the required pages of the tender document may result in the tenderer either being disqualified or forfeiting the available tender evaluation points, depending on the nature of the submission.

Electronic submission of tenders will **NOT** be accepted.

Telegraphic, telephone, telex, facsimile, email or similar apparatus of tenders will **NOT** be accepted.

The Department's requirements, preferred criteria, proposed terms and conditions to be applied in the sealing, addressing, delivery, opening and assessment of tenders are stated in the tender documents.

The Department reserves the right to cancel **OR** not to award this tender to any party.
