These cases originate from the time of Gauteng Shared Service Centre (GSSC). Responsibility for these cases was transferred to the Department of the Premier on 01 April 2016. The transfer process was not completed until the end of the financial year and therefore the cases were reflected as a contingent liability in the Annual Report 2015/16.


