














Gauteng COVID-19: Positive cases, recoveries, active cases and mortality








Gauteng COVID-19: Cases as at 6 August 2020











Gauteng COVID-19: New positive cases per day








Gauteng COVID-19: Average cases per week







Gauteng COVID-19: Regional breakdown of positive, recovered, active and deaths






Gauteng sub-districts as at 6 August 2020








Gauteng COVID-19: Highest Confirmed and active cases per sub-district








Gauteng COVID-19: Sub-districts with highest number of active cases








Gauteng COVID-19: Sub-district with highest number of recoveries


There is a total of 2 388 deaths recorded so far:

- 1 303 (55%) Male and 1 085 (45%) Female.
- 1 550 (65%) between the ages of 50 and 79 majority among these (893) being male. These are followed by the age groups 80-89 at 279 (11.7%), 40-49 263 (11%), and 33-39 130 (5.4%).
- 1 407 (59%) are 60 or more years old, and 949 (40%) are under 60 years of age.





Deaths Analyses: Days diagnosed/Admitted before death




- 1 510 (63%) of deaths occur within a week of diagnosis/ admission:
 - 986 (41%) within
 3 days,
 - 810 (34%) within two days, and 556 (23%) within a day or hours of diagnosis/ admission.
 - 773 (32%) occur after a week or more of diagnoses/ admission.





Deaths Analyses: Comorbidities



- 1 365 (58%) of deaths have either or both Diabetes and Hypertension, with most of these having:
 - 540 (23%) -Hypertension,
 - 449 (19%) Both
 - 376 (16%) Diabetes
- 535 (22%) have zero or unknown comorbidities
- 312 (13%) have other comorbidities

- Currently 4 688 patients are admitted in hospital, of which 1197 are in ICU and High care and 3 491 in the General Ward.
- There has been a significant decline in the daily new hospital admissions.
- The highest number of hospital admissions was recorded in the middle of July. The highest recorded daily new admissions was over 320 with the total number of admitted patients being 5748 and 1317 patients on oxygen as at 16 July.
- As at 5 August the total number of admitted patients was 4688 with 1 268 patients on oxygen.





Number of Gauteng Public Servants tested positive

- Out of 172 113 public servants in Gauteng, 5 242 have tested positive since March. This includes public Health workers and Educators.
- We have lost 2 Doctors from Dr George Mukhari Academic Hospital and Jubilee Hospital. We send our condolences to family, friends and colleagues of the two Doctors.
- Like all other patients, affected staff and their family members are receiving care and treatment in line with the World Health Organisation protocols.
- All other staff members who were in contact with those that tested positive have been tested and will continue to follow all protocols to prevent the spread of the virus.
- There is ongoing decontamination of all public buildings regularly as part of the measures to combat the spread of COVID-19.
- As part of continuous medical surveillance protocol, public servants undergo daily screening and some are referred for testing.

- Since the lockdown, 457 614 households have been provided with food relief, supporting a total of 2 288 070 people (at least 5 people per household).
- 368 175 calls received with an overall response rate of 111.4%. However, the municipalities do not source referrals via the hotline
- However, the demand for food far outstrips our capacity to meet the need.
- We continue to call for more support from business, foundations and civil society initiatives on food relief. However, such initiatives must be coordinated with government and the distribution should avoid breaching social distancing regulations.
- Food Distribution (National Picture): GPG accounts for 42.6% of the total Social Development Food Relief distribution across the country, followed by LP at 12.9%, MP and WC at 9.8% each.

- We are providing temporary shelter to the Homeless in 45 Shelters across the Province, working with municipalities.
- 2 712 homeless people are provided with 3 meals on a daily basis plus psychosocial support, medical assessments and treatment for substance abuse.
- 581 homeless beneficiaries have absconded from shelters to return to the streets.
- 579 have self-discharged themselves.
- 346 people were re-united with families from April – 10 July 2020.
- 953 people have been sent to Rehabilitation
 Centres for substance use disorders.

- Grade 12 learners returned to school on the 3rd August 2020.
- Teachers have been continuing with planned assignments ATP coverage,
 - Completion of SBA tasks,
 - Orals in languages
 - PAT components assessment.
- Schools to use the first four weeks after returning (August month) to complete the ATP as GDE plans to conduct Revision and Study Camps from September to December.

Status on Infrastructure

- 353 schools have been affected by Vandalism since the inception of the regulations.
- 8 schools have been reported since the start of the break (27-07-2020).
- 33% of the 353 schools have been affected more than once (repeat incidents)
- None of the initial 351 schools are closed as a result of vandalism.
- Repairs to vandalised schools
 - 163 schools out of the 351 schools are complete.
 - 351 contractors appointed.
 - Two additional schools' assessments have been done, the process is undergoing supply chain modalities.
 - Completion for the remaining work is anticipated for the end of August.





Nutrition

- Daily on average, the programme is now nearing 1,5 Million learners
- 166 649 Learners were fed from 27 to 31 July 2020
 - Normal feeding transported learners to schools to eat
 - Since 3 August, Grade 12 has returned to schools and are being fed in schools
- Feeding modalities are used for learners not yet back at school
 - Cooked meals are served on daily basis to children
 - School VFH and other PS staff deliver the food in a central point in the community and children collect at that distribution point
 - Some schools due to COVID-19 cases and not yet decontaminated are using nearby facilities e.g.
 Community Soccer grounds, Community Centres and Churches to distribute food parcels for learners on daily basis
 - Distribution of Food parcels on periodical bases such as every three days and also provided with learning activities
- Learner transported to schools to be fed on daily basis with lunch tins to collect cooked warm meals
- Community members demanding food parcels in schools that distribute to learners
 - Community members invading schools demanding food parcels. In one instance Police were called and principals explained to parents that the food is meant for children and they dispersed.





Scholar Transport

- The Department is currently transporting 42 000 learners in relation to the Grades that are back at school.
- The containment and prevention of the spread of COVID-19 in transit is managed through a collaborative effort with GDRT and DCS.
 - There are 120 disinfection centres across the province servicing contracted and private learner transport providers.
 - The decision to allow 100% capacity in public transport has adversely affected the learner transport sector.
- Scholar transport has resumed with grade 12 learners since 3 August





Safety at Schools

- GDE has strengthened security in schools by deploying patrollers
 - Patrollers have been deployed at no-fee paying schools to keep an eye on access control and report suspicious activity happening at the schools to the police.
 - All no-fee paying schools have been linked to their local police stations
 - Patrollers are to inspect the school perimeter to help prevent security breaches
- Private security guards have been identified for high risk schools
- Only learners, teachers, admin and other staff are allowed into the school premises and any service providers and other stakeholders must follow GDE guidelines in accessing schools during learning and teaching time which has been provided to SMTs and SGBs.
 - Visitors will only be allowed on an exceptional basis and after permission has been granted by the principal and in compliance with the communication guideline issued to schools.

Academic Support for Learners during Break

- The following two circulars issued was used to guide schools on Lockdown learning:
 - Guidelines for Home Education and Lockdown learning
 - School Closure, Lockdown and Remote Learning
 - Advise to parents was provided as per the parent guideline document on the DBE website.
- Guidance and support by district offices to schools:
 - Nature of instruction for home learning should be simple to follow and understand Memorandum/Rubric to be used by parents to monitor the progress of their children
 - Resource packs contain formative assessments on content being provided by teachers – All formative assessments are provided with memoranda which is marked and corrected at home and submitted to school for analysis.
 - District Directors to ensure that school principals develop and issue Learner Activity Packs (LAPS) for all grades to be supported at home.
 - District Directors must ensure establishment of Lockdown Learning Transversal Teams (LLTT) are established for virtual monitoring & support on any platform available to parents.





Digital Platforms and Partnerships

- The GDE provided zero-rated digital platforms to schools to share with parents, and to ensure that learners are provided with access to such platforms, however, it is clear that not all learners have equal access to such platforms.
- The GDE through partnership with the Click foundation targeting 500 schools in the province. The following programmes are available on Click Home learning programme: Reading Eggs, Matific (For maths), Feed the Monster and Care up. Schools were provided with login details. The majority of schools targeted are no fee schools.
- The GDE in collaboration with The WITS Early Grade Study embarked on an IsiZulu Home Learning programme using DBE workbook in the Johannesburg East district targeting over 8000 learners. Videos and workbook charts were provided to guide parents on how to help learners with workbook activities.





Support to learners at home without connectivity

- The department, through districts, will reworked the revised annual teaching plans and it will be packaged into learning activity packs (LAPS) for every 14-day learning cycle to be collected at school and signed off by a parent/legal guardian every 14 days.
- The LAPS will comprise, learning topics, topic summaries, step by step guidelines for tutoring, assessment tasks, memoranda, and zero-rated electronic media educational programmes.
 - Assessment tasks will be coordinated with classroom-based assessment programmes - parents will sign a commitment form to ensure fairness.
 - Where feasible, conference calls to be scheduled at specific times for learners to ask questions – where necessary – sanitisation rules apply.
- All assessment packs are to be returned to school every 14 days for marking and or quality assurance. And the Department will ensure that all examinations will be written at school within social distancing regulations, in exceptional cases, continuous assessment will be used.





Planning for the 24 August and beyond

- Enabling conditions
 - All the PPEs masks, sanitisers and related items were procured and delivered to schools for all grades returning initially returning on the 6 July
 - PPE for Grades 4,5, 8 and 9 will be delivered just prior to these grades returning in line with the just-in-time approach
 - Sanitisers, detergents and coveralls will be delivered on a monthly basis as per the demand from schools
- Teaching and learning preparations
 - Curriculum preparation based on the original plan has been completed with all schools but will be revised revised based on:
 - Adjustments for the break announced
 - Proposed New school calendar into 2021
 - Full details of minimum levels of learning for all grades except Grade 12
 - A detailed plan will be developed as soon in line with the revised calendar and revised ATPs

Update on PPE investigation









Update on investigation into PPE procurement

- The damning allegations of corruption regarding the procurement of Personal Protective Equipment have profoundly eroded public confidence in the collective work of the province in the fight against COVID-19.
- Last week, I made a commitment that we would give regular updates on the investigations based on the reports we received from the SIU.
- As you are aware, if in the course of investigations, evidence of wrongdoing is found, the SIU may refer such evidence to relevant authorities including the SAPS, NPA and SARS.
- The SIU may also recommend immediate action to be taken against any implicated officials.
- The SIU is empowered to take immediate steps to safe-guard assets which may include cancellation of contracts.





Update on investigation into PPE procurement

- Yesterday, we received an update from the SIU on their work regarding investigations into the COVID-19 procurement.
- The SIU is making headway in the ongoing investigations concerning COVID-19 procurement.
- Based on the evidence so far the SIU will be making referrals to other State institutions for action. A criminal case has been opened.
- The SIU has also identified two Gauteng Department of Health officials who have allegedly enabled and facilitated this procurement corruption. One of these officials will be served with suspension this morning while the one who has resigned will be pursued legally.
- With regards to other investigation already finalised by the SIU concerning irregular procurement at the Department of e-Government, we have already cancelled the contract and initiated disciplinary action against implicated officials.





Lifestyle audit for Executive Council

- In the 2019 State of the Province Address, I made a commitment that myself as the Premier and all members of the Executive Council (MECs) will undergo a lifestyle audit.
- We have engaged with the State Security Agency and next week they will commence with the lifestyle audit for myself and all members of the Executive Council.
- The audit is expected to be concluded within 6 to 8 weeks.

Concluding remarks









Containing the spread! Saving lives!

- We continue to implement the ward-based strategy as an intervention to contain the spread of the virus in line with of our comprehensive health response.
- Over the past two weeks, we have upscaled our ward-based strategy concentrating on areas with large number of active cases. This week we were in:
 - Johannesburg District Hotspots Protea Glen, Dobsonville, Jabulani, Doornkop
 - Ekurhuleni District Hotspots Primrose, Brackenhurst, Eden Park, Alberton
- All social partners are working together as part of the ward-based strategy to minimise community transmission through:
 - Identification of positive cases and expeditiously tracking and tracing contacts
 - Administering medical management to those who need it
 - Decongesting clinics
 - Referring people to quarantine and isolation sites based on assessment
 - Heightening awareness and education





Concluding remarks

- We are encouraged by the decrease in the number of new positive cases per week and a large increase in recoveries.
- The number of patients admitted is decreasing and is reducing pressure on the health system. We expected that in July and August were going to be the hardest months where the health system was going to be tested.
- We continue to increase our health capacity with our infrastructure programme and personnel capacity. The improvement in the infrastructure is a long-term investment in our health system.
- On Sunday, we will commemorate the heroic actions of the women of South Africa who
 confronted the brutality of the apartheid system. Basadi ba go swara thipa ka bogaleng.
- As we continue with the battle against this pandemic, we need to draw courage and resilience from the generation of women who marched against the injustice of the apartheid regime in 1956.
- As the provincial government we remain committed towards promotion of gender equality and women empowerment. It is central to our efforts of fighting poverty and stimulating sustainable development.





Concluding remarks

- Gauteng will be the home to all Premier Soccer League and National first division teams who will be completing the remainder of the 2019/20 season.
- Gauteng has state of the art infrastructure and sporting facilities which made the province the preferred choice for resumption of professional football under strict COVID-19 conditions.
- As we enjoy football, we must all continue to Play our Part in stopping the spread of COVID-19.
- Wearing masks, practicing physical distancing and observing the hygiene golden rules of washing hands or using sanitisers remain a powerful weapon in our hands to protect ourselves and those around us.
