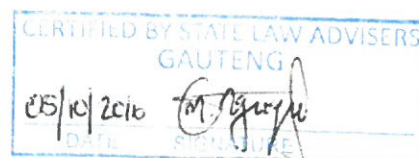
2. Schedule 2 of the Regulations is hereby amended by the substitution for the heading of the following heading:
