GAUTENG SPORT, RECREATION, ARTS AND CULTURE RELIEF FUND APPLICATION FORM - PHASE 2 – OCTOBER 2020

CRITERIA

Phase 2 of the Gauteng Relief Fund is open to INDIVIDUAL APPLICANTS

All individual applicants legible to obtain this financial relief/ assistance need to adhere to the guidelines below and ensure that their application form consists of the following supporting documents:

- Must be a South African citizen
- Must be a Gauteng resident

The following documents to be included with your application form:

- i. Certified ID copy not older than 3 months.
- ii. Bank confirmation letter for bank details
- iii. Proof of loss of income which could include any of the following:
 - ✓ e.g. proof of cancellation of event / programme/ (letter from organisers; affidavit, agreement)
 - ✓ Confirmation of work per Individual's event, gig or work. E.g. MOA/ Contract, Invitation/ appointment document, Booking schedule etc.
 - ✓ Invoices, deposit transactions reflected on the bank statement, purchase order etc.
 - ✓ League fixtures with dates, tournaments with dates.
 - ✓ Bank statement which shows loss of income.
 - ✓ Trading permit
- iv. **N.B Applicable to the Sport sector:**
 1. Athletes on SASCOC's OPEX programme are not eligible to apply)
- v. Applicants under the age of 18, requires a parent / guardian to submit the application on their behalf. Parent/ guardian and minor must submit a certified copy of their ID.

Stringent and audit/ checking processes will be put in place taking the above factors into consideration.

INSTRUCTIONS TO APPLICANTS

- a) This application form must be completed in full as any form of incompleteness shall result in immediate disqualification.
- b) Eligible to apply are any persons who meet the above set criteria and serve in the Sport, Recreation, Film, Television, Arts and or Culture sectors and who's work or event(s) was postponed or cancelled for the period **16 MARCH 2020 TO END SEPTEMBER 2020. (when the President made a State of Disaster announcement).**
- c) *Provision of false information will be treated as fraud and dealt with through appropriate Criminal Justice System.*
- d) *For online submissions, only PDF and or Word documents (all combined and submitted as one set of attachment) not exceeding 30kb capacity will be accepted.*
- e) *Applicant must not be receiving financial assistance from any other Sport, Recreation, Film, Television, Arts and Culture government, semi government or any other sector related source for the Relief Fund they are applying for.*
- f) *It is important that an applicant provides correct and accurate information to ensure a rapid and efficient application process.*
- g) *Sign off the application*
- h) **Submission Deadline: 19 October 2020.**

NB: The application process is adjudicated by an independent panel.
