CALLING ALL GAUTENG SPORT, ARTS, CULTURE AND RECREATION ORGANISATIONS TO SUBMIT PROPOSALS FOR PROJECT FUNDING FOR NPO'S SUPPORTING LIBRARY READING PROGRAMMES 2020/2021 FINANCIAL YEAR

NB: Due to the declaration of National state of disaster following the Covid-19 pandemic, proposals may be submitted virtually/on-line for projects appropriate for their sectors (library programmes)

The Gauteng Department of Sport, Arts, Culture and Recreation seeks to invest in library reading programmes (Library Services) that align with wider government objectives. The proposal must respond to the effect of COVID -19 on library programmes through the use of virtual/on-line solutions (4th Industrial Revolution initiatives) on the relevant digital platforms, video on demand, streaming, podcasts, social media, webinars and short animations that inculcate the culture of reading through our communities.

LIBRARY SERVICES PROJECTS

The Gauteng Provincial Library aims to promote the development of library and information services as well as to promote the use of digital library reading programmes.

In order to be considered, proposals must include library reading programmes that align with the 6th Administration priorities, which are:

- Transforming the economy to serve all people;
- Advancing social transformation including quality education;
- Keeping our communities safe;
- Stepping up to fight corruption;
- Re-building and renewing a capable and developmental state;
- Advancing nation-building and social cohesion;
- Building a better Gauteng and its citizens.

Proposals must consider the relevant Covid-19 Government Regulations and guidelines.

The following are requirements for qualification to submit and must be included in your proposal documents:

- Certified copy of Registration NGO Certificate
- Proof of registration with Central Supplier Database
- Valid vendor number of Gauteng Department of Finance
- Original Tax Clearance Certificate and a Certified copy of a Tax Exemption letter where applicable
- Certified copy of ID from the Project Coordinators
- Contact person and active contact numbers
- Certified copy of the last 3 months bank statements/ or letter from the bank for new accounts
- Costed Project Implementation plan
- Written endorsements from relevant public and private sector
- Only Gauteng based organisations may apply and projects must be implemented in Gauteng
- Previously funded applicants must have submitted all outstanding Progress Reports on any grants previously received from the Department of Sport, Arts, Culture and Recreation
- Non-Compliant applications will not be considered
- (All the above required documents must be submitted at the time of applications)
- Applicants that received funding in the past three years will not be considered for funding.
