<p>The Creative Industries Strategy aims to develop the creative industries and increase contribution to the economy, community development and urban regeneration. In order to be considered, proposals must demonstrate how they will:</p> <ol style="list-style-type: none"> 1. Invest in the development of cultural workers. 2. Develop and promote the products and services of creative clusters and enterprises. 	<p>In order to effectively implement the Gauteng Sport Policy and the Gauteng Sport Plan, the Department aims to call on the Sport and Recreation Organisations to submit proposals for projects that clearly demonstrate the following criteria:</p> <ol style="list-style-type: none"> 1. An increased number of people participating in sport and recreational activities and 2. leading to healthier lifestyles (Development and sport programmes in new areas). 3. Equal access and increased participation of women, youth and persons living with disabilities in sport. Capacity building programmes for sport administrators, coaches and technical official.

The following are funded through the Grants-In-Aid programme:

1. Sport, Recreation, Arts and Culture Organisations, Companies and Clubs
2. Projects to be funded should implement their programmes between April 2024 and March 2025.

The following compliance documents must accompany your application form:

1. Vendor number and most recent compliant CSD Report as per registration with the Gauteng Shared Services Centre (GSSC)/ Gauteng Department of Finance (GDF).
2. Most recent certified copy of organization/ company registration certificate.
3. Most recent certified ID copy of the coordinator and other key individuals involved in the project.
4. A certified copy of the latest 3 months bank statement (not more than three months old)/ letter from the bank for new Companies or Organisations corresponding with that on the CSD.
5. A certified copy of your most recent Audited financial statement dated and signed as approved by the directors, these must not be more than one year old/ Letter from the auditor for new Companies or Organisations.
6. Two written and signed reference letters from reputable referees (One from the municipality or ward councilor/ and second from Arts or Sport organisation).
7. Costed project implementation plan.

NB: - Non-compliant applications will not be considered and applicants without the above required documentation must consider their submission unsuccessful.

1. Only Gauteng based organisations/ companies may apply and projects must be implemented in Gauteng.
2. Fax, e-mail, incomplete and or late submissions will not be accepted/ processed.
3. Priority preference will be given to applicants that have not been funded previously and applicants that have received funding in the past three years will not be considered for funding.
4. All companies illegible do receive grants will not qualify for doing business with the state or Government.
5. All applicants must demonstrate how their programs will contribute towards Social Cohesion and Nation Building.
6. Consideration for funding will be at the discretion of the adjudication committee.
