

CALLING THE GAUTENG SPORT, RECREATION, ARTS AND CULTURE ORGANISATIONS TO SUBMIT GRANTS-IN-AID PROJECT FUNDING PROPOSALS FOR THE 2021/2022 FINANCIAL YEAR

Due to the National State of Disaster following the Covid 19 pandemic, applicants may submit virtual/ on-line proposals (appropriate for their respective sectors:

Sport & recreation and or arts & culture) that respond to digital solutions such as video online, streaming, podcasts, animation and documentaries to mention a few. Applicants must consider the relevant Covid-19 Government Regulations and Guidelines and also be able to provide evidence on the participants that participated on the virtual/ online platform.

For Sports and Recreation applications use REF: SACR/GIA/002/SR

For Arts and Culture/Heritage applications use REF: SACR/GIA/002/AC

Proposals should be able to demonstrate to some if not all of the following in the respectable sectors of Arts & Culture and or Sports & Recreation:

- Economic impact, job creation and infrastructure development.
- Education, skills revolution and health.
- Safety and social cohesion.
- Building a capable, ethical and developmental state

ARTS & CULTURE PROJECTS	SPORT & RECREATION PROJECTS
The Creative Industries Strategy aims to develop the creative industries and increase contribution to the economy, community development and urban regeneration. In order to be considered, proposals must demonstrate how they will: (1) Invest in the development of cultural workers. (2) Develop and promote the products and services of creative clusters and enterprises.	<i>In order to effectively implement the Gauteng Sport Policy and the Gauteng Sport Plan, the Department aims to call on the Sport and Recreation Organisations to submit proposals for projects that clearly demonstrate the following criteria:</i> - An increased number of people participating in sport and recreational activities and leading to healthier lifestyles (Development and sport programmes in new areas). - Equal access and increased participation of women, youth and persons living with disabilities in sport. Capacity building programmes for sport administrators, coaches and technical official.

The following are funded through the grants-in-aid process:

Sport, Recreation, Arts and Culture Organisations, Companies and Clubs

Funded projects should be implemented between March 2022 and June 2022.

The following compliance documents must accompany your application form:

- Vendor number as per registration with the Gauteng Department of Finance (GDF).
- Certified copy of organization/ company registration certificate.
- Audited financial statement(s) (Not more than 1 year old) or letter from the auditor for new companies or organisations.
- Signed and dated constitution/ Articles and memorandum of association/ Trust deed/ Company profile.
- Original tax clearance certificate and a certified copy of a tax exemption letter where applicable.
- Certified ID copies from project coordinators.
- Certified copy of the last 3 months bank statement/ or letter from the bank for new accounts.
- Costed project implementation plan.
- Letter of good standing from the ward council where event will take place.

NB: - Non-compliant applications will not be considered and applicants without the above required documentation must consider their submission unsuccessful.

- Only Gauteng based organisations/ companies may apply and projects must be implemented in Gauteng. Fax, e-mail, incomplete and or late applications/ documentation will not be accepted/ processed. All required documentation must be attached to the application form and be submitted at the time of applications.
- Preference will be given to applicants that have not been funded previously and applicants that have received funding in the past three years will not be considered for funding.
- All applicants must demonstrate how their programs will contribute towards Social Cohesion and Nation Building.
- Consideration for funding will be at the discretion of the adjudication committee.
