

# CALL TO SUBMIT PROPOSALS FOR SPORT, ARTS AND CULTURE EVENTS

The Gauteng Department of Sport, Arts, Culture and Recreation invites submission of proposals for Sport, Arts and Culture events or festivals for funding in the 2023/2024 financial year ending 31 March 2024. As part of the renewed emphasis of the 6th Administration for the Growing Gauteng Together (GGT2030) Provincial Plan and the elevated priorities for accelerated implementation of service delivery, the Department seeks to invest in Sport, Arts and Culture events and/or festivals that align with wider government objectives. The proposals must include events or festivals that create a platform for:

- Improved living conditions in Townships, Informal Settlements and Hostels (TISH)
- Increased participation for women, youth and person with disability
- Generating job creation opportunities for women, youth and person with disability
- Attracting local residents and results in localised social cohesion and economic impact.
- Growth in terms of audience, spectator and media profile.

The following are requirements for qualification to submit and must be included in your proposal document:

1. Proof of Company Registration/ NGO/ Co-operative
2. Valid Original Tax Clearance Certificate and Pin number
3. Proof of Registration with the Central Supplier Database
4. Certified Copies of ID of members or shareholders
5. Detailed Company Profile with references
6. BBBEE Certificate
7. Bank Confirmation Letter for Account
8. Costed Project Plan
9. Written endorsements from relevant public or private sector organisations
