COVID-19 Expenditure Disclosure Report







PART A

Background

On 15 March 2020, President Cyril Ramaphosa announced the declaration of the National State of Disaster following the World Health Organisation declaring the COVID-19 outbreak as a pandemic. Subsequently National Treasury and Gauteng Provincial Treasury (GPT) issued several SCM instruction notes and circulars, which provided guidelines pertaining to the emergency procurement process for COVID-19 PPE and related goods and services.

1. Introduction

In line with the National Treasury SCM Instruction Note No. 11 of 2020/2021, MFMA Circular 105 of 2020/2021 as well as the Gauteng Provincial Government's commitment to publish all the COVID-19 procurement transactions on a monthly basis in order to promote transparency and accountability in the public procurement, the third COVID-19 Disclosure report is herewith published. Detailed institution's reports will further be published on the National Treasury Website

The report covers the COVID-19 procurement transactions for the period October 2020 for the Gauteng Provincial Departments, Entities as well as the 8 Delegated Municipalities and includes the following information.

- a) COVID-19 payments per Institution
- b) Suppliers names and payments
- c) COVID-19 items (goods and services) procured
- d) Supplier CSD registration numbers

2. Reporting Methodology

As prescribed in the abovementioned National Treasury Instruction Note and MFMA circular, the Gauteng Provincial institutions submitted individual reports on the National Treasury's prescribed reporting template to the Gauteng Provincial Treasury for publication purposes.

3. Overview of the COVID-19 procurement transactions: October 2020

In the month of October 2020, a total amount of R364,022,752.57 was spent on COVID-19 related goods and services. Out of the total amount paid, 99% was spent by the Gauteng Provincial Departments that reported on time, i.e., Department of Education, Department of e-Government, Department of Human Settlement, Department of Agriculture and Rural Development and the Department of Infrastructure Development, Department of Health and Department of Economic Development. The Department of Community Safety did not have transactions to report on.

Out of all the reported entities only Gauteng Growth and Development Agency recorded covid19 related payments of R51,491. The following entities recorded nil payments for COVID-19 related items however there were transactions concluded in the month under review which were not yet due for payments i.e. Cradle of Humankind World Heritage Site, Gauteng Infrastructure Funding Agency, Gauteng Tourism Authority. This report, therefore, excludes transactions concluded but not paid. Detailed Institution's reports with all transactions (paid and not paid) are provided as links to this report.
